

<b>FACTS</b>	WHAT DOES PPR OPPORTUNITY FUND 1 – CLEAN CARS EQUITY, LLC (“PPRCCE1”) DO WITH YOUR PERSONAL INFORMATION?		
<b>Why?</b>	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.		
<b>What?</b>	The types of personal information we collect can include:		
	<u>Sensitive Information</u> <ul style="list-style-type: none"> <li>■ Social Security number</li> <li>■ Income</li> <li>■ Credit worthiness/credit history</li> <li>■ Bank account information</li> </ul>	<u>Personal Identifiable Information</u> <ul style="list-style-type: none"> <li>■ Account balances</li> <li>■ Transaction history</li> <li>■ Names and contact information</li> </ul>	
<b>How?</b>	All financial companies need to share customers' personal information to run their everyday business; for example, to service your account and to conduct the business of PPRCCE1. In the section below, we list the reasons PPRCCE1 chooses to share certain customers' personal information, and whether you can limit this sharing.		
<b>Sensitive Information</b>	PPRCCE1 does <u>not</u> share “sensitive information” other than in connection with the storage of information for its everyday business purpose of maintaining and processing your account, which information may contain such sensitive information. In addition, we limit access to this information. You cannot further limit this very restricted use of such information.

<b>What We Do</b>	
How does PPRCCE1 protect personal information?	To protect personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.
How does PPRCCE1 collect personal information?	<p>We collect personal information, including sensitive information and personal identifiable information, for example, when you:</p> <ul style="list-style-type: none"> <li>○ Subscribe for an interest in our company;</li> <li>○ Qualify to subscribe for an interest in our company by and through third party vendors hired by us to verify certain information;</li> <li>○ Provide certain contact information, including possible employment information;</li> <li>○ Provide us certain income information.</li> </ul> <p>We also collect your personal information from others, such as credit bureaus, affiliates or other companies.</p>
Why can't I limit all sharing?	<p>Federal law gives you the right to limit only:</p> <ul style="list-style-type: none"> <li>○ Sharing information about your creditworthiness for affiliates' everyday business purposes;</li> <li>○ Affiliates using your information to market to you;</li> <li>○ Sharing for non-affiliates to market to you.</li> </ul> <p>State laws and individual companies may give you additional rights to limit sharing.</p>
What happens when I limit sharing for an account jointly held with someone else or by and through a company owned by others?	Your choices will apply to all beneficial owners of such account/entity.
<b>DEFINITIONS</b>	
Affiliates	Companies related by common ownership or control. They can be financial and nonfinancial companies. Our affiliates include PPR Opportunity Manager, LLC, PPR Note Co., LLC, PPR Capital Management, LLC and such additional affiliates under common ownership or control, as applicable.
Non-Affiliates	Companies not related by common ownership or control. They can be financial and non-financial companies. Non-affiliates with which we may share certain information include third party vendors such as technology companies engaged to store information or provide other services related to your account.
Joint Marketing	A formal agreement between nonaffiliated financial companies that together market financial products or services to you. Though no such joint marketing currently exists, joint marketing partners may arise in the future.
